GENERAL TERMS & CONDITIONS

This agreement sets forth the terms and conditions under which Boscov's Travel & Apple Vacations in return for payment of the amount indicated as the total price, agree to provide this tour.

PAYMENT INFORMATION: An **INITIAL DEPOSIT** of **\$250 per person** is due by **SATURDAY, JUNE 29, 2019**; along with this signed reservation form in order to secure your room and air seat. A **2nd DEPOSIT** in the amount of **\$200 per person** is due by Wednesday, July 31, 2019. A **3rd DEPOSIT** in the amount of **\$300 per person** is due by **Tuesday, October 15, 2019**. A **4th DEPOSIT** in the amount of **\$250 per person** is due by **Tuesday, December 3, 2019**. **VERY IMPORTANT:** After December 3, 2019, space will be subject to availability and will be at the current and prevailing rates. Final payment, full names, date of birth, and gender of **ALL PERSONS** traveling are due on or before **WEDNESDAY, JANUARY 15, 2020**. If final payment is **NOT** received by deadline date, reservation will be automatically cancelled and deposit will be forfeited. **No extensions or exceptions will be permitted.**

IMPORTANT INFORMATION: All rates and space are subject to availability at time of booking. All rates are based on a minimum of 20 fully paid adult passengers and 10 rooms at double occupancy and are subject to increase should this minimum not be met. **A COPY OF YOUR PASSPORT WILL BE REQUIRED AT THE TIME OF AIR TICKETING.**

CHARTER AIR CANCELLATIONS: Regardless of reason, cancellations are a costly process. Insurance benefits are not payable for any loss due to, arising or resulting from: 1. suicide, attempted suicide or any intentionally self-inflicted injury of You, a Traveling Companion, Family Member or Business Partner booked to travel with You, while sane or insane; 2. an act of declared or undeclared war; 3. participating in maneuvers or training exercises of an armed service, except while participating in weekend or summer training for the reserve forces of the United States, including the National Guard; 4. riding or driving in races, or speed or endurance competitions or events; 5. mountaineering (engaging in the sport of scaling mountains generally requiring the use of picks, ropes, or other special equipment); 6. participating as a member of a team in an organized sporting competition; 7. participating in bodily contact sports, skydiving or parachuting, hang gliding or bungee cord jumping; 8. piloting or learning to pilot or acting as a member of the crew of any aircraft; 9. being Intoxicated, or under the influence of any controlled substance unless as administered or prescribed by a Legally Qualified Physician; 10. the commission of or attempt to commit a felony or being engaged in an illegal occupation; 11. normal childbirth or pregnancy (except Complications of Pregnancy) or voluntarily induced abortion; 12. dental treatment (except as coverage is otherwise specifically provided); 13. amounts which exceed the Maximum Benefit Amount for each coverage as shown in the Schedule of Benefits; 14. due to a Pre-Existing Condition, as defined in the Policy.
