



This agreement sets forth the terms and conditions under which we, Boscov's Travel and Avalon Waterways, in return for payment of the amount indicated as the total price, agree to provide this tour.

**PAYMENT INFORMATION: A NON-REFUNDABLE** deposit of \$350.00 per person along with the reservation coupon is due at time of booking (Single Occupancy will require \$600 per person). Rates and cabins are subject to availability at time of booking. **FINAL PAYMENT IS DUE NO LATER THAN JULY 11, 2020.**

**IMPORTANT INFORMATION:** Any changes made to your reservation once deposit has been received will be subject to a fee at the discretion of the airline and/or cruise line.

**PAYMENTS:** You may charge any portion or the entire amount on your Boscov's Charge, Master Card or Visa. If paying by check, make it payable to Boscov's Travel.

**AIR TRANSPORTATION:** Round trip air transportation is included between Philadelphia and Paris (including air taxes, government fees and fuel surcharges, which are subject to change at the discretion of the airline).
